Tom Gordy serves as the President of the Armed Forces Marketing Council, a position he has held since March 2008. In this role, he works to support and enhance the military resale benefit for military families by engaging with congressional, Department of Defense and military resale industry leaders to address issues of concern to the members of the Council.
