WHEREAS, the allocation has increased the budget in some areas and decreased in other areas with a net revenue and expenditures budget increase of \$2,748,929;

**NOW, THEREFORE, BE IT RESOLVED,** that the Prince William Board of County Supervisors does hereby accept, budget and appropriate ongoing funding authorized by the United States Department of Housing and Urban Development in the amount of \$2,748,929 in the Office of Housing and Community Development's fiscal year 2018 adopted budget to reconcile differences between the County's adopted budget and actual funding allocations from the United States Department of Housing and Urban Development.
