# **EPIDEMICS DUE TO** FLIES AND FILTH

#### Infantile Paralysis and Dys entery Endangering Lives of Many People.

Richmond, Va., July 24. At widely separated points in Virginia, two epimics are now endangering the lives of many people. In the vicinity of Fredericksburg and in the city itself infantile paralysis has been occurring since the last day of June, and on the south side of Middle river in Greene and Madison counties an outbreak of and Madison counties an outpress of bacillary dysentery has already re-sulted in more than a hundred cases of sickness and ten deaths. During of sickness and ten deaths. During ralysis outbreak there was only one fatality

Epidemics Due to Faulty Sanitation. Laboratord tests have proved that the dysentery outbreak has been caused by intestinal bacilli; and this is giving the State Board of Health much concern because in the Middle river district there is absolutely no sanitation, even of the simplest sort and flies in droves carry the germs in Held Near Kettle Run on Old Home all directions.

While Fredericksburg is generally well sanitated; the houses having sewer connections, the surrounding dis-tricts of King George, Spottsylvania and Stafford counties are far from being as satisfactory. Both in the city and in the counties there are too many flies.

#### TAXES ALL AROUND

It isn't possible to run the government or run anything else without taxes. If a man tries to run himself along life's highway he soon discovers the journey takes taxes. Should he be fool enough to try to run away from communities, people and things and go to a place that is not taxed, where would he go? He might go to the North or South Pole, but even there he would soon learn that the atmosphere would suddenly and swiftly levy a deadly tax on his person even shoud he bury his property to escape taxation. Should he find a place on earth that is not taxed in some way he would certainly have the distinction of flocking all by himself, which would not last long.

If a man owns farm land or other real estate he is apt to think that it is taxed beyond the limit of justice. If he owns stocks, bonds and mortgages he will think the same thing. If he carries heavy life insurance and fools himself into thinking that he thereby escapes taxation, he is very much mistaken. If he is wise he will carry fire is not taxed, because it is. Whence comes the more than \$10,000,000 per year which Virginia levies for the purpose of running the government? From a number of sources, but nearly one-tenth of it comes from the insurance companies doing husiness in the state. For the year ending May 1, the various kinds of insurance companies, including life, fire, disability and double indemnity, industrial and sick benefit, paid into the treasury of Virginia the sum of \$995,489.73. Of that sum the life insurance companies paid \$521,303.43, or more than half. In other words the holders of life insurance policies, not including industrial and sick benefit insurance, are paying more than onetwentieth of the total cost of running the state and government.

Yea, verily, there are taxes to the right of us, taxes to the left of us, taxes all around! But it is better to pay taxes and have the benefits therefrom than not to pay and do without some of the best things in life,-Exchange.

#### **DIVERTING ROAD FUNDS**

One of the peculiar facts in the road bond campaign in Virginia is that the appeals of the pay as-you-go advocates apparently fall on more fruitful soil in the rural communities than in the urban This is true in spite of the fact that imones. proved highways will be more immediately beneficial to the farming sections of the state than to the cities

Persistent propaganda on the part of the antibond leaders, used for the sole consumption of the country districts, probably is the reason for the hostility many farmers have manifested toward bonds. A favorite appeal to the rural dweller is that, if the state is saddled with a bonded debt of \$50,000,000, his land some day will be sold at auction for heavy taxes he will be unable to pay. That erroneous statement has had the effect of scaring off farmers who realize fully the benefits of improved highways, but fear the risk the payas-you-go propagandists say they will run in approving a bond issue.

There is one thing about their plan, however, that the antibond leaders have not impressed upon that the antibond leaders have not impressed upon voters in rural communities with the zeal they display in other directions. It is that, without the issuance of bonds, the fund which has for voors been used exclusively for highway maintenance will be diverted to construction purposes. This is the program of Governor Trinkle, as submitted to the Legislature in his appeal for the mitted to the Legislature in his appeal for the pay-as-you-go method of financing road building, and no leader of his faction has proposed any dif-What did you give that one of yours when he had it?"

'feeder" roads? That, it is said, is the plan of the bond advocates. The pay-as-you-go leaders, if they are successful in blocking the move to have the Legislature issue bonds for the construction of roads, would render it impossible to give this intended aid to the farmers in keeping up their county highways.

That is just one of the many things to keep in mind as you vote this fall on the bond issue proposal.—Times-Dispatch.



ferent plan. It is presumed, therefore, that diversion of a part of the maintenance fund is approved by Governor Trinkle's co-workers and it will be done in case the antibonders are victorious in the election this fall.

The Governor, in his table showing the sources of money which may be used under the pay-asyou-go plan of financing highway construction, includes surplus maintenance funds; that is, money in excess of that needed to maintain roads already built. This surplus will increase year by year as the number of automobiles, upon which license fees going into the maintenance fund are paid, increases. It constitutes a very considerable part of the revenue Governor Trinkle would use for road building in lieu of money derived from the sale of bonds.

This fund heretofore has been held inviolateavailable for no purpose other than maintenance of highways. It is the contention of the bond issue proponents that it ought to be kept inviolate. If at any time there is more than enough money derived from automobile licenses to-maintain the state highways already constructed, why not apportion it among the counties for maintenance of "Turpentine; giddap."
