Having been appointed Chairman of the Drought Relief Committee I have a few suggestions to make to the farmers of Prince William County.

First, Do not sacrifice your live stock. Keep all you can possibly feed through the winter.

Second, If you have no hay or fodder, use straw for long feed, and cotton seed for grain, as cotton seed meal is the cheapest grain you can ed cattle. Third, Raise all your good heifer calves as there is always a good demand for good cows.

Fourth, Do not keep any scrub calves, keep the well-marked holstein

and guernseys. Buyers from Pennsyl-vania, New York and other states prefer buying cows from Virginia, as this climate is such that our cattle do well shipped to most any part of the United States. By ARTHUR BRADY (No. 3) It takes the bees as long to make the honey comb as it does to fill it with honey. So the modern houseper uses a machine called a ho extractor, removes the honey from the combs and sends the "empties" the combe and senas the empirical back to the bees to be filled again. Thus a great saving is made in the bees' time just when they are busiest A honey extractor is a sort of metal tank about as large as a bar-rel, with a screened framework in-side made to whirl around at the rate rel, with a screened framework in-side made to whirl around at the rate of 280 revolutions per minute. Honey for extracting comes in large combs about 8x18 inches. When the bees have filled and capped the combs the beeman pares off the capping with a sharp knife and places the combs in the "baskets" inside the extractor, which is then put in motion, and the honeycombs go whirling like a regu-lar honey "merry go round," and in a few minutes all the honey has been whirled out of one side and is drip-ping down inside the extractor. When one side of the comb is cleared of and the process repeated until the honey the "baskets" are reversed, other side is emptied. The combs are new ready for the bees to ill again, while the honey is drawn off into a tank and strained, through cheese-eloth or wire, and is ready for use Not all beeksepers extract their honey alike. 


