#### **EXECUTIVE SUMMARY**

#### **Department of Facilities & Fleet Management**

#### Facilities Construction Management (FCM) Division

- <u>Adult Detention Center Phase II Expansion</u> Final Occupancy Permit was issued on October 9, 2020. Staff has moved in over the course of several months. The integration of the electronic security system with the Main Jail continues with anticipated inmate move -in sometime in February 2021. http://mydesktop/apps/CXOProjMgr/Intranet/InetDetail.asp?ProjId=835
- <u>Animal Shelter Expansion</u> David Smith, Project Manager, with Michael Baker International is scheduled to present a construction update on this project to the Board at its afternoon meeting (2:00pm) on February 9 as part of the Capital Projects Quarterly Project presentation. http://mydesktop/apps/CXOProjMgr/Intranet/InetDetail.asp?ProjId=857
- <u>Groveton Fire and Rescue Station 22</u> Substantial completion occurred on December 4, 2020. The Department of Fire and Rescue moved in and took calls on January 2, 2021. http://mydesktop/apps/CXOProjMgr/Intranet/InetDetail.asp?ProjId=875
- <u>Courthouse Security System & Lobby Expansion Project</u> –Phase 2 of the lobby portion of project is 95% complete. Interior finishes have been installed, the storefront is complete and ballistic security film has been applied. Pending the interior glass security partition installation, and subsequent scanning equipment relocation, the project should be finalized by the end of January. The security system upgrades are approximately 50% complete and on-schedule. Access control wiring has been installed; card-readers are being added and replaced throughout. Intercom speakers and associated wiring are being installed. Emergency call boxes have been installed. Camera installation is pending ethernet switch and rack installation.

- <u>Public Safety Training Center Master Plan Update</u> –The update is completed and will be presented to the Board in March 2021. <u>http://connectapps.pwc.ad/apps/cxoprojmgr/intranet/InetDetail.asp?ProjId=881</u>
- <u>Judicial Center Complex Master Plan Update</u> –Procurement Services has signed off on the task order. The Purchase Order (PO) is in progress. Juvenile Services Center Planning Study – FCM met with the users to reduce the square footage of the proposed building and to look at how it will fit on the existing site. Revisions to the costs due to the reduction in beds and square footage and the location change are pending. The project will be completed in two phases. Phase 1 consists of the new Juvenile Services Center (JSC) some parking, and utilities. Phase 2 includes demolition of the existing building and construction of the new Molinari Juvenile Emergency Shelter, connection to new JSC and parking. http://connectapps.pwc.ad/apps/cxoprojmgr/intranet/InetDetail.asp?ProjId=915

#### Property Management (PM) Division

- <u>Chinn Library Parking ADA</u> This project used Building & Facilities Program (B&FP) funding. It includes Americans with Disabilities Act (ADA) compliant sidewalks and parking as well as replacement of existing exterior stairs. - <u>Ferlazzo Building Exterior ADA Improvements</u> This B&FP project includes installation of ADA sidewalks, ADA parking and ADA ramps/railings. The sidewalks and parking are now in use. The railings on retaining walls in the front of the building is completed. - <u>Parks Fleet Building Repair</u> This B&FP project includes repair of hairpins in the floor slab and other code/safety-related updates to the building. The hairpin repair construction is completed. - <u>Ferlazzo Building Atrium Ceiling Replacement</u> The B&FP program previously funded the replacement of ceiling in the hallways. Staff took advantage of the significantly reduced occupancy in the building due to COVID to perform replacement of the atrium ceiling. The project is now complete.

#### Department of Parks, Recreation and Tourism (DPRT)

#### Solid Waste (SW) Division

• Balls Ford Road Compost Facility - The Second Amendment to the Amended and Restated Service Agreement for the Organic Waste Facility was signed by the Board in December 2020. New technology has been developed since original service agreement. Phase II will now use "In-vessel Advanced Aerobic Composting" to replace "Anaerobic Digestion." Phase I of the construction was completed in July 2020. Site is now taking Category 1, 2 and 3 food waste. Phase II construction (In-vessel Advanced Aerobic Composting) will begin late spring of 2021 with a scheduled completion date of August 2022.

- <u>Landfill Liner Design and Construction of Phase III, Cell A</u> Design has been completed. Bids were received and opened January 19, 2021. Contract award is anticipated mid-February 2021. - <u>Revise and Update 2004 Solid Waste Management Plan</u> The current Solid Waste Management Plan (SWMP) was approved on June 22, 2004 and needs to be updated considering current technologies and trends in the industry. The Solid Waste Fee was adopted in and implemented in 1999 and the process used to determine fee amounts needs review for consistency and accuracy. Expertise from a consultant to lead the County through a community process to guide the SWMP for the next 10-20 years is needed. The overall goal of the SWMP is to reduce the amount of waste entering the County Landfill. A review of the Solid Waste Fee and possible long term funding options for the system will be included in the study. 


