OMNIRIDE Western Facility Opening



Purpose: Official opening of Western Maintenance Facility

Updates:

- Roughly 1/3 of the fleet is stored at the new facility.
- Reduces long non-revenue travel across the County to commuter lots.
- Capacity available to expand services in western County (local and commuter).
- Will support I-66 express lanes and future development.
- This is the last report for this project.

Purpose: Construct an access road leading to Planet Direct







- Bids opened on July 12, 2021. On August 3, 2021, the Board awarded a \$21,985,000 construction contract to Branch Civil for the project.
- Notice to Proceed and the construction kickoff meeting occurred on August 17, 2021.

Transform 66- Outside the Beltway

Purpose: Construct two new express lanes in each direction on I-66 from I-495 to Gainesville (University Boulevard) and multimodal improvements to address current congestion and future needs

Updates:

- Construction activities are ongoing: retaining walls being built; blasting continues; beam lifts; Park and Ride construction; and interchange construction in Fairfax.
- Paving for future traffic shifts.
- Traffic impacts and lane closure information are available to the public at transform66.org.





- A final reverse agreement (ELUP) with VDOT was received and is currently being reviewed for presentation to the Board in September 2021.


Purpose: Construct new south-facing ramp between Opitz Boulevard and the Express Lanes

Overview:

- New south-facing access ramp connecting the 95 Express Lanes and Opitz Boulevard.
- During northbound operations, the ramp will provide northbound 95 Express Lanes users the opportunity to exit onto Opitz Boulevard near Potomac Mills Mall and Sentara Northern Virginia Medical Center.
- During southbound operations, the ramp will provide access from Opitz Boulevard to the southbound Express Lanes.
- Proposed ramp will be within the existing median between the southbound I-95 General Purpose lanes and the 95 Express Lanes and connect to an expanded Opitz Boulevard bridge over I-95.
- Sidewalk will be provided on the north side of the Opitz Boulevard bridge.





Retaining walls, underground detention ponds, drainage, curb and gutter and asphalt build-up is ongoing.

Status: Under Construction

- Utility and waterline relocations began August 2018
- Duct bank and waterline relocations completed November 2019
- Road widening construction advertisement ended-September 2020
- Roadway construction ends Summer 2022
- Current Appropriation: \$100,199,894
- Project Funding: Federal, State, Regional, and Local













Route 28 Bypass



Purpose: Construct a bypass in the Route 28 Corridor

Updates:

- A scope clarification meeting was held with the design consultant on July 15, 2021.
- The consultant's price proposal was submitted in August 2021. Negotiations are ongoing.

Status: Under Design

- Design began September 2021
- Design ends March 2025
- Construction begins August 2025
- Construction ends October 2027
- Current Appropriation: \$92,392,491
- Project Funding: Regional and Local

OMNIRIDE I-395 Commuter Choice



Purpose: To continue operating new/enhanced services to the eastern end of the County service area.

Updates:

- OMNIRIDE applications to NVTC to continue operating 7 projects from the Commuter Choice grant, including:
 - Increased peak frequency on the Prince William Metro Express between Woodbridge and Springfield Metro.
 - Increased peak local bus frequency on the Route 1 local service.
 - Continued funding of 2 additional morning and afternoon trips from Dale City/ Horner Road to Rosslyn/Ballston.
 - New commuter service from Stafford County to DC.
 - New commuter service from Stafford County to the Pentagon.



Status: Approved by Commonwealth Transportation Board to Continue Operations.









OMNIRIDE I-395 Commuter Choice



Purpose: To continue operating new/enhanced services to the eastern end of the County service area.

Updates:

- \$200 monthly parking benefit for Vanpools in urban core.
- Supplementary \$400 monthly payment for vanpools using the corridor.

Status: Projects were approved and went into effect 7/1/21. They will operate for two years.











OMNIRIDE Other Grants



Purpose: To continue to diversify commuting options for county residents and remove barriers to access.

Updates:

- TANF Grant application to increase access to commuter services for low-income residents.
- DPRT Capital grant to look at viability for mobile ticketing that was placed on hold for FY21 due to Covid-19 restrictions.

Status: TANF grant is active and will run through June 30, 2022. The mobile ticketing grant was awarded again for FY22, and we are in negotiations with vendors to bring a demo product to market.











OMNIRIDE Zero Emissions Bus Study



Purpose: To study emerging alternative fuels for transit fleet

Updates:

- Scope of Work in process of being developed
 - Determine Infrastructure needs
 - Best practices of agencies that have implemented
 - Review products offered by various manufacturers
 - Demonstrator vehicles for testing
 - Training of staff
 - Develop timeline for implementation

Status: Scope of work development in process. Should begin study Fall 2021 with completion mid-2022; any new vehicles would be evaluated after completion of study.







OMNIRIDE Mobility Councils



Purpose: Provide a forum for public input and dissemination of information.

Updates:

- OMNIRIDE to staff, identify partner organizations, and implement up to three Mobility Councils in FY21:
 - Vanpool Council active (partner Vanpool Alliance), assisted in the development of Vanpool Parking Benefit project for Commuter Choice.
 - Business Council active (partner GMU), working to develop travel tracking information for employers.
 - Hispanic Council active, had inaugural meeting in December 2020 and second in March 2021.

Status: Business Council active and met virtually in May 2021. Vanpool council met in April 2021 and will meet again in the fall. Hispanic council working with elected officials and community representatives to enhance bus ridership and service awareness in high Latino population areas (e.g., Georgetown south.) Focusing on authentic messaging and equity.









VRE COVID-19 Response



Purpose: Adjustments to service and protection to employees and passengers

Updates:

VRE adjusted service:

- 1,379 average daily riders as of March 2021.
- "S Plus" schedule continues to operate (18 daily trains).
- March 17, 2020: began operating a reduced schedule ("S" schedule or 16 daily trains).

The following procedures and protocols have been implemented for staff and passengers:

- March 13, 2020: staff began working from remote environments.
- Provided train crews and other front-line staff PPE (masks, sanitizer, social distancing).
- Enhanced cleaning of passenger coaches and facilities with an emphasis on high-touch surfaces.
- Installed graphics to make social distancing on trains and at stations as simple as possible.
- Installed hand sanitizer dispensers in stations and on trains.
- Implemented Federal and state orders requiring face masks for passengers.

Status: Continued monitoring of passenger loads; continued additional cleaning protocols and social distancing.




