**RE: AUTHORIZE A PUBLIC HEARING TO REQUEST THE
COMMONWEALTH TRANSPORTATION BOARD TO CONSIDER
RESTRICTING THROUGH-TRUCK TRAFFIC ON WATERFALL
ROAD/HOPEWELL ROAD, STATE ROUTE 601 – GAINESVILLE
MAGISTERIAL DISTRICT**

ACTION: APPROVED

WHEREAS, Waterfall Road/Hopewell Road is not designed or intended to serve heavy truck traffic; and

WHEREAS, Waterfall Road/Hopewell Road is not recommended for trucks due to the roadway design; and

WHEREAS, heavy truck traffic causes safety problems on Waterfall Road/Hopewell Road; and

WHEREAS, an alternative route exists via James Madison Highway, Route 15, in Prince William County to Interstate 66 in Prince William and Fauquier Counties to Exit 31, Old Tavern Road, Route 245, in Fauquier County/Fauquier Avenue, Route 245 in the Town of Plains to Main Street Route 55 in the Town of Plains to Loudoun Avenue, T-626 in the Town of Plains; and

WHEREAS, the alternate route is depicted on the attached map; and

WHEREAS, Section 46.2-809 of the Code of Virginia mandates that a public hearing must be held by the local governing body to receive public comments on restricting through-truck traffic on any part of a secondary highway; and

WHEREAS, the Prince William County Police Department will be responsible for enforcing the restriction; and

WHEREAS, the Gainesville District Supervisor received this request;

NOW, THEREFORE, BE IT RESOLVED that the Prince William Board of County Supervisors does hereby authorize a public hearing to request the Commonwealth Transportation Board to consider restricting through-truck traffic on Waterfall Road/Hopewell Road, Route 601, in the Gainesville Magisterial District;

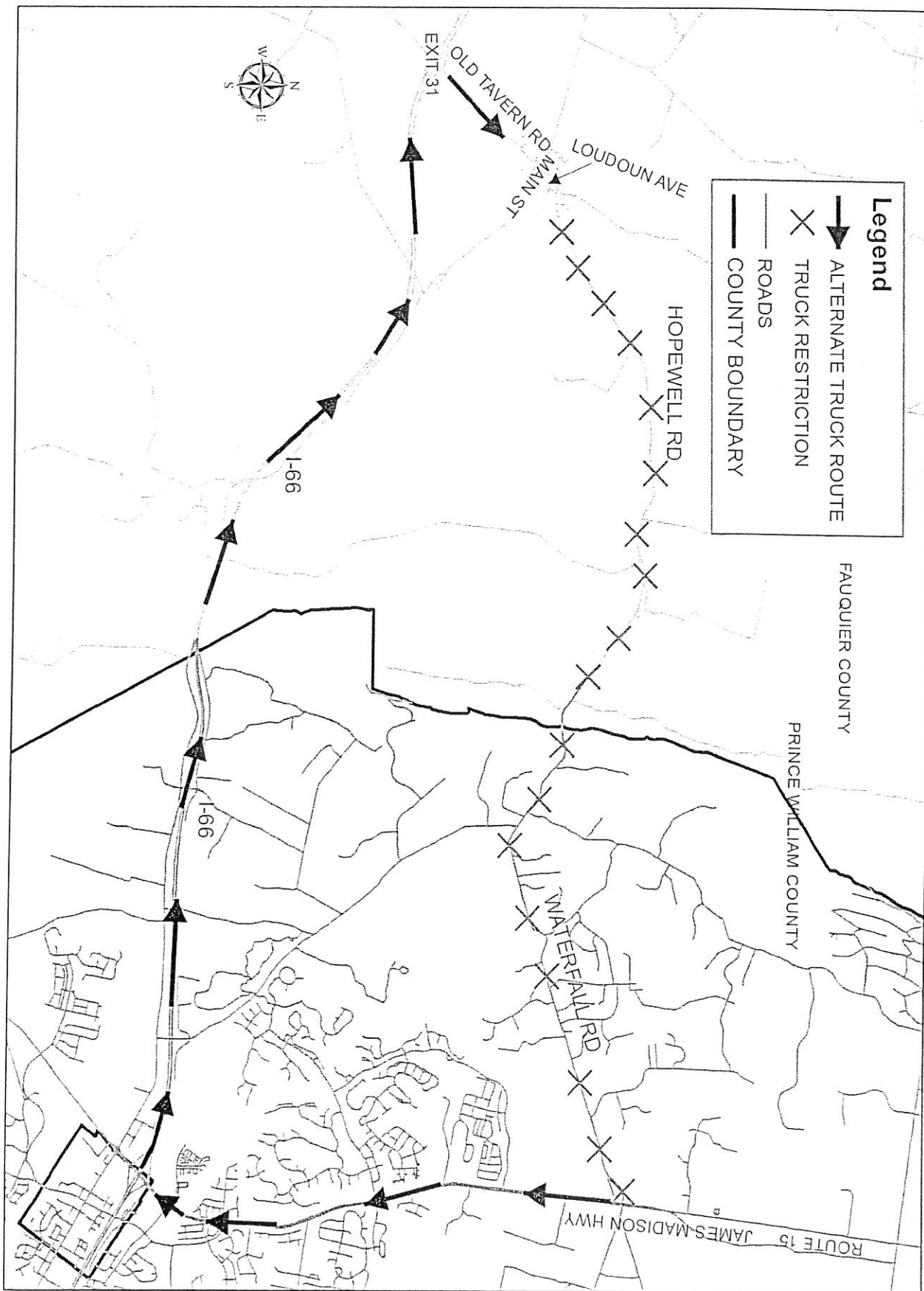
