The Human Heart.
Editorial in the New York Herald.

Dr. Beverly Robinson of this city, the well-known authority on heart disease, has much to say in a recent issue of the American Journal of Medical Science, not only regarding the study of Poe's life in Richmond, but on the various causes of heart affections, as applied to our modern methods of living. As Dr. Poe spent his last evening in Richmond and where possibly he took the first drink which led to his death a few days later in Baltimore.

The lady who claimed that Poe told her she was the "Lenore of the Raven," was Miss Sarah Elmina Royster, afterward Mrs. Shelton.

She was familiarly called "Poe's Lenore" to the day of her death. She was the first sweetheart.

This and the sacred passion for Mrs. Jane Stith Standard, the wife of his beautiful law, were the great ties of Poe's youth.

He met Miss Royster in the spring of 1825, when under a special tutor he was preparing to enter the university of Virginia in February of the next year.

When Poe returned to Richmond for the last time in the summer of 1849, Mrs. Shelton was a widow. The attachment of earlier years was renewed. Mrs. Shelton herself has given a graphic account of this first meeting.

The heart is a wonderfully constructed dynamic pump, with a working energy of seventy years and more, but it must be treated as any other valuable machine, with due care as to capacity, strength, and endurance. But the opposite is so much the case that it is time to think and act in a reasonable way before it may be regretfully impossible to do so.

Not only does this important vital organ become organically affected as the result of rheumatism, pneumonia, typhoid fever, diphtheria, grippe and Bright's disease, but in a more indirect way by pure overuse of function. Under the latter circumstances weakening and dilatation of the cardiac walls are most apt to occur, and damage the victim to a greater or less extent for life.

In these cases it is perhaps not so much the weakness of the heart itself as the lack of nervous force behind the trouble. Obviously between these dates she had moved, the slightest systemic disturbance may seriously affect the organ. A sudden straining, even of short duration, is frequently very injurious and often fatal. A heart once fairly dilated is too often permanently damaged. Like a skin, heart is likely to shy on the slightest provocation.


