

LETTER TO MRS. BUSHONG

Writer Describes Beauty and Delightful Climate of the Bermuda Islands.

The following very interesting letter from Miss M. F. Proctor of the Bureau of Chemistry, Washington, which was received by Mrs. M. F. Bushong, of near Manassas, will doubtless prove of interest to our readers:

DEAR FRIEND:—I have been promising myself the pleasure of a few minutes' grace for some time so that I might write you a letter.

I have just returned from a delightful trip to the Bermuda Islands, as you know, are of white coral formation built up on the erater of a submarine mountain said to be fifteen thousand feet high.

The climate is simply an oceanic climate, like that on a vessel out on the ocean. Being a group of islands (365), without mountains, and lying in mid-ocean over six hundred miles from either continent or island, it has an evenness of temperature.

The highest elevation is two hundred and sixty feet, but in order to level the roads the coral hills were cut through, leaving high walls on either side, and they are at frequent intervals covered with flowering vines and overflowing with blossoming shrubs.

On each side of the great chancel were depicted scenes from the life of the Christ. Over the chancel was a large window which was a striking representation of Gethsemane.

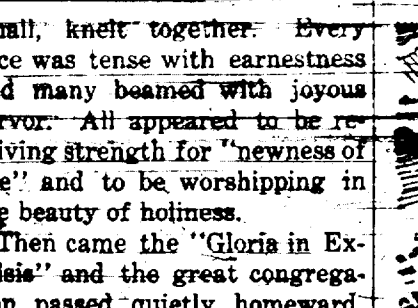
As I did not intend to write a guide to Bermuda when I commenced this letter to you, I have bored you with this long drawn out affair.
