His remarkable personal magnetism has always been a big cash-getter, and whatever the issue at Baltimore he will doubtless continue to draw.

His interests are not paramount, nor should they be permitted to dominate the convention. But simple justice demands for him just the same consideration that is accorded any other successful man.

THE POLITICAL PROBLEM.

Political paroxysms continue. The delirium at Chicago has been equalled by the convulsions at Baltimore. The infection in both instances has been personal ambition and personal interests and not patriotism.

In the one case there were thousands who ardently believed in Mr. Roosevelt; in the other Mr. Bryan holds powerful sway.

In both instances the personal influence of one man is a decisive factor, always a dangerous thing. It is not so much Mr. Roosevelt's "policies" that men believe in but the man. It is not so much Mr. Bryan's principles that have carried thousands but the magnetism of the man.

Which is the better and safer man? That is the whole problem. At least we know that Mr. Bryan has been a consistent "progressive" for years. He has not jumped into a tidal wave. He forced its movement. He is the author of this new political creed; and if we are to have progressivism, it is fitting that either Mr. Bryan lead or that he name the leader.

We have never been Mr. Bryan's "booster," but as a matter of practical politics he is the man. Certainly he seems the only one who can save us from Roosevelt, and he is a safer, saner man.

BUT BEFORE WE DO. Mr. Bryan, a thrice-defeated man, has at least succeeded in awakening and converting thousands to radicalism. Both political parties have become infected and this so-called progressivism threatens the very form of all our institutions, and we are gravely told that our constitutional fabric needs remodeling.

Perhaps; but where would you go when once you begin to tear down? You have told us that our judiciary must sit at the will of the people, at the whim of popular acclaim; that matters involving not only the property of the individual but even his liberties must be tried by the temper of the crowd. It is nothing more or less than full sway to Judge Lynch.

What time is there for sober reason, when agitation and agitator hold sway over the public mind? At best, man does not think any too well. At best our courts have not been any too good, but would it improve matters to install the mob as judge? Too, you say our financial system is all wrong and everybody is at the mercy of predatory wealth.

Are you sure of this? If you are going to regulate at least let us know the ability and character of the men who purposed doing the regulating. Besides, just what are you going to do with this "predatory" wealth? Are you sure you have been robbed, or have you simply been less provident than the other fellow?

Really, has either Morgan or Rockefeller robbed you of a single dollar one way or the other? Moreover, are not great corporations nothing more or less than progressive business? Have we not all been more or less deceived by the clever phrase-maker?

REGULARS OR STANDPATTERS. Will strive to enact the necessary legislation to safeguard the public health.

While we regard the recall of judges as unnecessary and unwise, we favor action to simplify the process by which derelict judges may be removed.

We favor additional legislation to prohibit corporations from contributing funds to campaigns for President, Vice President, senators and representatives.

We favor the establishment of a system of parents' post.

We condemn democratic House for refusing to authorize construction of battleships.

We believe one of country's most urgent needs is a merchant marine.

We favor a liberal and systematic policy for improvement of rivers and harbors.

We pledge appropriate laws to give relief from constantly growing evil of undesirable immigration.
