## HISTORIC SITE FILE: Antioch Baptist Church PRINCE WILLIAM PUBLIC LIBRARY SYSTEM RELIC/Bull Run Reg Lib, Manassas, VA

We the membership of Antioch Baptist Church, Waterfall, Virginia, Prince William County, Virginia, in a duly called meeting of the church in session July 14, 1964, hereby approve the following resolutions and requests:

Whereas we believe that it is the good pleasure of our Almighty Father that Christians forsake not the assembling of themselves together for divine worship:

And whereas we believe a Christian Church should be actively engaged in the divine business related to the Kingdom of God:

And whereas we the members of Antioch Baptist Church, having taken stock of our present condition, and having reached the conclusion that a solution other than seeking to maintain an active church in our present building and location is desirable:

And whereas, being in close proximity to Her daughter church, the Haymarket Baptist church, Haymarket, Prince William County, Virginia, we can join in Holy Worship, Study of the Scriptures, and work in His Kingdom through that church:

And whereas we feel that the day may soon come when it will be desirable to re-open the Antioch Church; and that we desire the present membership to be in a position to actively engage themselves in the care, upkeep and control of our present property and funds:

We therefore resolve and request of the Haymarket church the following:

1. To receive into full membership those present members of Antioch who shall present themselves for membership at any of Haymarket's services;

2. To accept title to the property of Antioch Church and such funds as may be in the church treasury;

3. It being understood that should the Antioch Church be re-activated



in the future, the Haymarket Baptist Shurch will transfer title to the said property to the Antioch Church.

4. It likewise being understood that the funds received from the Antioch Church will be carried in the Budget of Haymarket Church as a special item designated as Antioch reserve and be used by the Haymarket Church for the repair, maintenance of buildings, cemetery, etc. so located on the property transferred from Antioch Church, and further any income derived from such property will go into the Antioch reserve.

We hereby direct that a copy of this resolution be mailed to the last known address of each of our members thereby encouraging them to become members of an active church of their choice;

And notify them that after a period of three months that no membership roll of Antioch will exist.
