Don Wilson told me you would be the best person to ask about a discrepancy on two historic site files 076-0533 and 076-0322 that have the same address – 10214 Lonesome Rd.

The Balch-Reid-Bean House, commonly called Bean House is at 10214 Lonesome Rd, Nokesville, has the site number 076-0322. We have the file here in RELIC.

In 2002, I asked for a list of the files the Planning Office had. Your site file 076-0533 is labeled House, 10214 Lonesome Rd. We do not have this file # here in RELIC. Does 076-0533 have a Virginia Historic Landmarks Commission survey form? What is the Historic name on that file?

I am wondering if your file 076-0533 is the same as our 076-0322 about the Bean House? If they are the same property, what number should the Bean House have and how do you eliminate the other number?
