



Pursuant to a decree of the County Court of Prince William dated the 2<sup>nd</sup> day of May 1829 Appointing Col<sup>l</sup> W<sup>o</sup> Howe Rob<sup>t</sup> Hamilton Th<sup>o</sup> Hamilton & James Mich<sup>l</sup> Gentlemen as commissioners to divide the estate of Justice John F. Chinn Part in Part in Part & part in Part in Part & under the directions of the Commissioners I have surveyed the Tract of land above represented Beginning at an Elm on the base line near a ledge of Clove Run N 78° 21' 11" pole to a stump of white Oak (at 2) then S 77° 10' 2" pole to a stake (at 3) then S 26° W 182 pole to a white log a branch (at 4) then S 73° W 180 pole to a planted stem or then S 28° W 180 pole to an old stump by a branch (at 5) then S 88° 30' 0" pole to a planted stem on the N. of the paved road (at 6) then S 85° W 308 pole to a stump

at the mouth of Spring branch (at 7) then down North Lane & bounding with the meadows of the same to the mouth of Spring branch (at 8) then S 70° W 296 pole to a white Oak (at 9) by the new market road then S 20° W 294 pole to a corner shew by 20 lines beginning then S 53° 25' 29" pole to the second white Oak at 101 then S 105° 23' 1" pole to 14 this corner was not called with the line (at 11) then S 51° 16' 20" pole to a corner (at 12) then down D Lane to the beginning of a corner 3569 pole 38 4/5 poles in length then down D Lane to the mouth of Clove Run & then up D Lane to where Hady's road crosses the field to B a red white Oak on Lewis Mill road then with D road to the corner of Hady's (at 13) white Oak then S 53° W 301 pole to a stake in D Lane (at 14) then S 53° 42" pole to the beginning of a corner on the N. of the paved road to the beginning of the line of 737 pole & road 4 10 3/4 pole & begins to lead at 21 & Hady's by the Sary F. Chinn road at the beginning of the estate & bound with the old line of the same (at 22) a stone pole 54 pole from the planted stem to a stone pole then S 73° 30' 11" pole to a white Oak on Lewis Mill road then with the old road & back Lane to the corner of 3569 pole & is allotted to Prucilla Hady on the N. of the paved road & then with the old line (at 23) on the N. of the paved road & then with the old line (at 24) then with the line of (at 25) to a white Oak on Lewis Mill road then with D road to the corner of 3569 pole & is allotted to Sary F. Chinn then with Lewis Mill road (at 26) to a white Oak on D Lane then S 73° 30' 11" pole to a corner (at 27) 188 pole to a stone pole (at 28) 26 pole from a stump (at 29) then with the old road to a corner & is allotted to Sary F. Chinn
