Beverley Mill is a five-story stone structure with an additional attic story set in the metal covered gable roof. Due to the mill's position on the lower slopes of Thoroughfare Gap in the Bull Run Mountains, the up-hill (north) side is only three stories high and faces a century-old branch of the Southern Railway. The hugh structure, four bays on its main front and three bays on the sides, is constructed of partially-coursed stone rubble quarried from the creek and mountainside with window openings of six over six sash. The water power was provided by Bull Run Creek which, in its 1300 foot passage through the Gap, drops 87 feet. Exterior mill machinery remaining includes the 29 foot metal waterwheel and sluice gate as well as the stone mill race. The interior is inaccessible at the present time.

In appealing for the preservation of the structure, one group noted that the mill had

contributed essential food products for five Wars--beginning with the French and Indian War. The Mill is mentioned in old orderly books and in the public claims for the Revolutionary War. Supplies were shipped to American troops during the War of 1812, the Mexican War and during the Civil War the Mill was used (alternately) by Union and Confederates.

The mill was designed exclusively for the milling of corn for meal and feed, but, during ante-bellum Virginia's agricultural revival, its operations were expanded to include the grinding of limestone for fertilizer. The mill was modernized by a new metal waterwheel in 1900 and in the 1940's by flour grinding equipment and a diesel engine for auxiliary power. In the 1940's the mill ground approximately 100,000 bushels of grain annually and employed six persons.

Thus Beverley Mill -- this imposing mass of stone masonry within view of the thousands of motorists who travel through Thoroughfare Gap each year, this anciently designated official county boundary marker which has contributed bountifully to feeding Virginians and others during peace and war -- is indeed a landmark in the broadest and best sense.


