The Tyler family, as the Love family, was integral in the establishment of the Town of Buckland. This 1796 document enabled the establishment of the original town of Buckland east of Broad Run (see faxed Plat entitled "Broad Run Tract")

This Indenture made this 26th day of December in the year of our Lord one thousand seven hundred and ninety six Between George Gray Tyler and Cecilia his Wife, of the County of Prince William and State of Virginia of one part, and John Love of the County aforesaid and State aforesaid of the other part. Witnefseth, That the said George G. Tyler & Cecilia his Wife for and in consideration of one hundred dollars to them in hand paid, the receipt of which is hereby acknowledged, hath granted, bargained and sold aliened and confirmed unto him the said John Love his Heirs and afsigns for ever a certain tract or parcel of land, situate lying and being in the County of Prince William in the State aforesaid, on Broad Run, beign part of a tract of land saidd George G. Tyler purchased of John Campbell, beginning at two Hickory's in or near Carters line and running thence with said Carters line, South thirty five and a half degrees, West twenty five poles to Broad Run, thence down the (last sentence/first page) and binding thereon to a marked Hickory and red oak sapling a hill side and close to said Run, a corner to said Tylers land of which this is a part and some distance below the present ford, on the main road leading from the Red House (today Haymarket) to John Loves Mill, thence a direct line to the Beginning, containing twenty five acres, one road 28 poles and all houses, buildings, trees, waters, profits and commodities whatsoever to the said tract of land belonging or in anywise appurtaining and the various remainders, rents, issues, profits, thereof and of every part and parcel thereof, To have & To Hold to him the said John Love the said tract of Land and all and singular the premises hereby granted unto him the said John Love his Heirs and Afsigns, to the only proper use & behoof of him the said John Love his Heirs & Afsigns for ever, and the said George G. Tyler dowth for himself his Heirs and Exectors covenant, grant, and agree to and with thte said John Love his Heirs and Afsigns that he George G. Tyler is now at the time of sealing and delivery of these presents seized in his overright of a good and sure Estate in fee simple in the said tract of Land and premifes hereby granted without any manner of Mortgage, use or limitation, to alter, change or bridge the same and that he the said George Gray Tyler will at all times hereafter at the request and at the cost and charge of him the said John Love or his Heirs, execute and acknowledge any further Act and Deed for the more certain afsuring and conveying the said tract of Land and premifes unto him the said John Love his Heirs and Afsigns, as by him the said John Love his Heirs or Assigns or any of their counsel learne in the Law shall or may be advised or required. And lastly that he the said Geo. G. Tyler and his Heirs, the said tract of Land hereitaments and all and singular the premises hereby granted with their and every of
