



Investigating Rights

It is the user's responsibility to determine the copyright status or obtain required permissions before publishing or distribumaterial from the Library's collections. The nature of historical archival collections means that copyright or other informat about restrictions may be difficult or even impossible to locate. Clues regarding information relating to rights may be deriv from notations on the images, such as copyright notices and creator and source names, as well as image dates. When explicit rights information is lacking, patrons must conduct a "risk analysis" to determine appropriate use of an image. Th involves coupling their knowledge of rights principles (such as duration of copyright, the definition of "published," and the definition of "fair use") with information supplied on the image and found in Copyright Office records.
