5. DESCRIPTION:

Deed old and torn.

6. HISTORICAL SIGNIFICANCE:

"THIS INDENTURE made this 20th day of August, one thousand eight hundred and five, Between George Legg and Phebe, his wife, of the one part and of the County of Loudoun and the of Virginia, and Robert Ware, of the County and State afor of the other part, WITNESSETH, that the said George Legg & Phebe, his wife, for and in consideration of the sum of fi pounds current money, to him in hand paid by the said Robe Ware at and before the sealing and delivery of these prese the receipt whereof is hereby acknowledged, they the said Legg and Phebe, his wife, have granted, bargained and sold

certain tract or parcel of land, lying and being in the T of Buckland, and County of Prince William, the lot known : Town as lot No. 32, and is bounded as appears in deed date third day of June, 1799, with buildings aforesaid."
