Buckland July 7th 1798

A Law having been enacted by the General Assembly of Virginia on the 15th day of January in the year one thousand seven hundred and ninety eight for establishing a Town on the lands of John Love in Prince William County, which Town is called Buckland and we William Tyler, Alexander Scott, Britton Sanders, Robert Thrift, William Brookes, Richard Gill, William Huntow Edward Carter & Thomas Huntow having been constituted Trustees thereof have in pursuance of the direction of the said Law advertised the lots in the said Town for sale for two months successively and appointed this seventh day of July for the day of sale of the said lots or such of them as under the said Law we are authorized to sell, and having accordingly sold the same to the persons and in the manner following to wit.
