Divorce Evil.

Bar Association to Endeavor to Check It In Pairfax County.

The committee of the Fairfax Bar Association, Mesers. Thomas R. Keith, Wilson M. Farr and George B. Robey will, during this term of the court, take up with Judge Brent the question of checking the growing divorce evil in this county. It is contended that many persons desiring severance of the marriage ties establish a fictitious residence in Fairfax county in order to file application for divorce in the county.

It is the purpose of the Bar Asso ciation to have regulations adopted that will prevent residents of the District of Columbia coming into the county, and, by renting a room in which they stay but seldom, claim a residence in they county, as is required by the divorce laws. It is proposed, if possible, to put up the bars, so that only bona fide residents of the county can sue for divorce in

the Fairfax County Court.

## Cold Weather.

The coldest weather of the winter visited Pairfax and vicinity Satur day night of last week, and tem peratures as low as 4 degrees above zero were registered by thermometers in town. Thick ice formed on all the streams hereabout, and in many homes water systems froze up and gave-trouble before they were thawed out. The weather moderated Sunday afternoon, and Monday it was warm enough to soften up the frezen ground. Tuesday some sleet fell and with it came disagreeable weather conditions.

Herndon School Burned.

FIRE DESTROYS FINE STRUCT-URE SATURDAY LAST.

Classes Resume Work in Congregational Church and Hotel Building. New School to be Erected.

A fire, of undetermined cause, destroyed the school building at Herndon Saturday afternoon last, the building being gutted, little of its contents being saved. The structure was valued at about \$25,000. The fire was discovered about dusk Saturday afternoon, and, though the Leesburg fire department came to the aid of the Herndon firefighters, a shortage of water prevented the firemen from doing much to combat the flames. Efforts were made to save some of the school equipment, but, beyond a few chairs from the auditorium, little else was saved. The building stood in an eight-acre field, and its distance from other buildings, and the favorable direction of the wind, prevented the flames spreading. An entertainment had been given in the school auditorium Friday night and was to have been repeated Saturday night, and many fine costumes belonging to, or borrowed by, members of the cast, furniture borrowed for stage fittings and other borrowed material for the play were burned up, making the loss to many individual residents of Herndon quite heavy. The fire raged for several hours, and all that is left of the building is the walls, which seem to be quite firm.

The school authorities have secured the Congregational Church of Herndon and the Herndon Hotel, and in them classes have been started, the high school in the church and the grades at the hotel. Books and other paraphanalla were in the book store in the Fairfax School building, so that Supervisor Woodson was able to furnish most of the books needed by the time the school locations had been secured.

The burned building cost over \$25,000 when built esveral years ago, and within the past two years an addition was erected at a cost of \$12,000. While no plans for the construction of a new building have been started, and will not be until the insurance is adjusted, there is no doubt but that one will be erected in the coming spring and summer.
