House consists of two parts: l_2 story section (prob. dates to late 19th century) which was remodeled in the early 1970's and to which was added the 2-story section.

A pair of double doors once in the gable end of the older li-story section have been installed in the house across Logmill Rd., belonging to Mrs. Beth Wells.

Interior inspected? Yes.

Historical significance (Chain of title; individuals, families, events, etc., associated with the property.)

The older section of this house once served as the feed and grain storage section of the W. R. Gossom Store, part of which was moved across Logmill Rd. in the 1930's.

This building may have been the original location of the Hickory Grove Post Office, which operated at this crossroads from 1875 to 1911. The building may also have served the commercial operations of Thomas Taylor, who operated a gristmill at Hickory Grove from the late 19th to the early 20th centuries, and of T. R. Galleher, a farmer and general store owner.




