Willcoxin.

1881 Mar. 28. In his will, Benjamin Johnson gives 200 acres of his homestead farm to his niece Mary Selecman. Will probated 5 Dec. 1881. [Will Book T: 307] He gave lands to the east to his nephew Benjamin Cockerell. Former servant Benjamin Mitchell has lifetime interest in 10 acres. Former servant Rosetta King receives 18 acres on the north side of the farm. Former servant Burk Mitchell receives 50 acres. Other relatives to receive proceeds of sale of other property. [Will Book T:307]

1822 June 18. Benjamin Johnson from John Macrae, administrator of George Graham, deceased, based on contract with Benjamin's father Rutt Johnson, 17 June 1822. 804 acres, "Graham Park," late the estate of said George Graham. [DB 8: 335] Includes plat, which shows boundaries, roads, streams, and location of a house.
