Battlefield May Expand

A U.S. District Court jury has
cleared the way, temporarily at
least, for a 312.5-acre addition to the
Manassas National Battlefield Park
by recommending that the federal
government pay \$4.2 million for the
extra space.

government pay \$4.2 million for the extra space.
Officials at the battlefield and the U.S. Department of Justice say the price tag recommended by the jury is about \$3 million too much.
"I don't think (the cost of the land) reflects just compensation of the property," said Rolland R. Swain, superintendent of the battlefield. Swain and justice department officials said Friday that the federal government likely will appeal the jury's decision.

The justice department is repre-

senting the battlefield and the United States in the land condem-nation suit.

nation suit.

Manassas attorney Tom Underwood represents the heirs of Walker Davis, owners of the 312.5-acre site on U.S. 29-211 north of Manassas.

"Justice was done—I'll put it that way," Underwood said of the jury's finding Friday.

Sources said that a property appraiser for the Davis estate valued the Davis property at just over \$1

An appraisal firm hired by the justice department estimated the property at \$812,000, sources said.

Swain said he thinks the jury may have misunderstood its options when it recommended that the Davises be paid \$4,218,750 for the land or about \$13,400 an acre. land, or about \$13,400 an acre.

The current 3,660-acre park is located just north of Manassas along Sudley Road and Lee Highway. The southern edge of the Davis property borders the western section of the park near Stonewall Memory Gardens Gardens

About 3,000 feet of the property's western edge parallels Pageland Lane, according to a map provided

Lane, according to a map provided by Underwood.

Developers have been buying large parcels of land in that area in recent years. At the same time, federal officials have been trying to protect the park from development by acquiring land there.

The Davis property already ap-pears as part of the battlefield on most county maps, although it had not been officially acquired by the government.

George Frampton, president of the Wilderness Society, announced the list Tuesday morning, according to a society spokesman.
The Manassas battlefield was included on the list because "it is a high profile Civil War battlefield, identified around the country as of national significance, and it illustrates the urban encroachment that threatens national parks across the country," said Steve Whitney, director of the national parks program for the society.

The Hazel Peterson Cos. and the Edward J. DeBartolo Corp. jointly plan to build a 1.2 million square foot regional shopping mall as the centerpiece of a mixed development on land adjoining the local park.

The common threat that links the 10 parks is the "external threat issue," said Whitney. "Parks are not islands. They are part of a larger historical or natural area.

"It would have been easier to list 50 units," he said. "The hard part was whittling the list down to 10."
