# Haymarket OKs rezoning of historic Payne property

The Haymarket Town Council on Monday approved Don Costello's request to rezone the historic Payne property from residential to commercial use to benefit the town's economy, but the move isn't unanimously considered to be good for the town.
"You will see a for sale sign in

my property tomorrow," said Betty Jo Santangelo, who lives adjacent to Payne house.

(The project) has generated a considerable amount of discussion, thought and study," Mayor Jack Kapp said as he made his recommendation to the council. "It all boiled down to one question: about 10 years and needs sub-

market?"

"I do not feel Mr. Costello to upgrade the site. wants to raze the building. I believe he wants to fix it," Kapp added. "I feel the rezoning is in the best interest of the town."

Costello, owner of Century Stair Co., adjacent to the Payne property, purchased the house in December and plans to use the building as an office before converting it into a restaurant. He also plans to build a small guest lodge as well as retail shops and offices on the site.

At Fayette and Washington streets, the Payne house was built in the 1800s as a summer resort, but has not been occupied for

> Santangelo purchased property on Fayette Street in December, before the Payne proposal was made. A week after she moved in the house in February, she learned that the historic building could be zoned for commercial use.

> Santangelo has invested \$15,000 in the restoration of her property and has hired an attorney to try to halt the project. She doesn't object to commercial development, but said the plan should be moved elsewhere.

"I hope where you go to vote you're voting frm your heart, not

out of fear and intimidation," she told the council Monday.

Other opponents are concerned that Costello has not guaranteed preserving the Payne house. They fear that the property will be razed if the project does not meet expectations.

"I don't see any reason why it can't be guaranteed," said Michael Kyle, chairman of the Payne House Preservation Committee.

Most council members anticipate that the commercial venture will revitalize the property and contribute to the town's economy.

"I was dead set against it, and I didn't want it," said council member Steven Bean, who voted in favor of the project. "I was scared like everybody else. (But) the town can use the revenue. Other businesses can use the revenue."

"I had many sleepless nights trying to weigh this," said council member Nancy Bailey. "When I was elected to this office, it was for me to represent the town and what I feel is best for the town.

"I have come to a conclusion for the town. This is the best thing we could ask for."
