## Planning

- **Applicant's Final Submission for Planning Commission** – This is the last date to submit the final application package to make this Planning Commission hearing date. The Planning Office closes at 5 PM.
- **Acceptance of Final Submission/Notice to Applicant/Signs Ready for Pickup** – If the final submission is deemed complete by the Planning Director, this is the date notice is given to the applicant that their project is scheduled for hearing. Public hearing notice signs are prepared for pickup and the request for an updated Adjacent Property Owners list is requested of the applicant.
- **First Newspaper Advertisement** – This is the date the first ad will run in the newspaper. Applicant should verify that their case is advertised.
- **Adjacent Property Owners List Due to Planning Office** – This is the date the updated Adjacent Property Owners list is due to the Planning Office. The Planning Office closes at 5 PM.
- **Public Hearing Signs Must Be Posted** – This is the date that the public hearing signs must be posted on the property.
- **Second Newspaper Advertisement** – This is the date the second ad will run in the newspaper. Applicant should verify that their case is advertised.
- **Planning Office Report Dispatched/Sign Posting Affidavit Due** – This is the date the staff report is dispatched to the Planning Commission and made available on the website. Sign Posting Affidavit is due to the Planning Office by 5 PM.
- **Request for Expedited Review by Planning Commission Due** – This is the date a request to be placed on the expedited agenda is due to the Planning Office by 5 PM.
- **Applicant's Presentation Due** – The applicant's presentation is due to the Planning Office by 5 PM.
- **Planning Commission Public Hearing** – Planning Commission hearings start at 7:00 PM in the Board Chambers. The applicant must be in attendance and present their application to the Commission.
- **Applicant's Final Submission for Board of County Supervisors** – This is the last date to submit any changes after the Planning Commission hearing to make this Board of County Supervisors hearing date. The Planning Office closes at 5 PM.
- **Acceptance of Final Submission/Notice to Applicant/Signs Ready for Pickup** – If the final submission is deemed complete by the Planning Director, this is the date notice is given to the applicant that their project is scheduled for hearing. Public hearing notice signs are prepared for pickup and the request for an updated Adjacent Property Owners list is requested of the applicant.
- **Adjacent Property Owners List Due** – This is the date the updated Adjacent Property Owners list is due to the Planning Office by 5 PM.

- **Planning Office Report Dispatched to Board of County Supervisors** – This is the date the staff report is dispatched to the Board of County Supervisors and made available on the website.
- **Second Newspaper Advertisement** – This is the date the second ad will run in the newspaper. Applicants should verify that their case is advertised.
- **Applicant's Presentation Due** – The applicant's presentation is due to the Planning Office by 5 PM.
- **Board of County Supervisors Public Hearing** – The Board of County Supervisors hearing is on this date. Consolidated agenda items will be heard at 2 PM and regular hearing items will be heard at 7:30 PM in the Board Chambers. The applicant must be in attendance and present their application to the Board.
